## A note from the executive director


This year's Buffalo Hospital Foundation Annual Report reflects the enthusiasm and commitment of the community in supporting exceptional care, close to home.

## CANCER CARE AT BUFFALO HOSPITAL – OFFERING INNOVATIVE AND COMPASSIONATE CANCER CARE, CLOSE TO HOME

The ability to provide quality oncology care close to home was a fundraising initiative for the Buffalo Hospital Foundation in 2013. By exceeding their goal and raising gifts that totaled \$240,000, the foundation funded the new Virginia Piper Cancer Institute® – Buffalo Hospital – a center that provides compassionate, community-centered cancer care.

### EXPANDED SPACE.

The newly renovated space combines clinic and infusion services that reach the standards of a nationally accredited cancer program. At 3,350 square feet, the Virginia Piper Cancer Institute – Buffalo Hospital contains essential dedicated space that offers patients a healing, comfortable environment with the comforts of home.

“Traveling to the metro, worrying about traffic and parking in ramps adds to the exhaustion of cancer care,” Cancer Care Coordinator, Jody Mattson, said. “Here in Buffalo, we follow the same national guidelines as large cancer centers, and our team collaborates with the oncology team in the metro when needed. Yet we maintain the ‘small town’ atmosphere.”

Allina Health had a goal to pair a cancer care coordinator with each cancer patient. In this role, as an experienced registered nurse, Mattson provides support and assistance to patients and their families by helping them efficiently navigate the medical system, from

diagnosis through treatment and follow up. She ensures all questions are answered and confirms the patient has a solid understanding of their treatment plan.

Mattson said the new space not only allows her to conduct this work more effectively, but more importantly, it offers needed comforts to patients and their families. “It is essential for patients to have dedicated space for cancer care so they can receive the extra attention they need,” she said. “The space allows us to make the environment more like home, peaceful and relaxing during a stressful time.”

### THE COMFORTS OF HOME.

In the infusion suites, where patients receive chemotherapy, you’ll find heated chairs, flat-screen TVs, DVD players and recliners for guests. iPads are also available for use during treatment visits.

In addition to a refreshment center and resource library, the expansion created space for professional wig and undergarment fitting services, which are therapeutic to patients as they experience changes with their bodies throughout treatment.

Additionally, dedicated staff members are now able to work in close proximity to the patients they serve – creating an atmosphere of accessibility. “This reduces the fear, worry and

uncertainty that patients often experience,” Mattson said. “Having care in the same space allows for patient confidence. They know how to get to their appointments.”

In the instance that family members aren’t able to attend appointments, they are still able to participate via conference call – just one more way Virginia Piper Cancer Institute - Buffalo Hospital offers close-to-home care.

### CARE TEAM CLOSE AT HAND.

Our specially trained staff works alongside the center’s care team which includes a medical oncologist, surgeon, genetic counselor and pathologist. Physical and occupational therapy,

lymphedema therapy, adaptive devices, pain management alternatives and nutritional support are also available.

The Virginia Piper Cancer Institute – Buffalo Hospital is proud to offer quality services and compassionate cancer care to anyone seeking cancer services in the community.

“Since opening, patients who were getting care in the metro have decided now was the time to transfer their care back to Buffalo,” Mattson said. “And it feels so good to be able to welcome our patients back home!”

To introduce the new space, Buffalo Hospital hosted an open house event and invited the community to visit the space, meet the staff and learn more about cancer care options at Buffalo Hospital.

“Through the campaign, we were able to create a patient-centered environment that is comfortable for patients in all stages of their treatment,” said Heeter. The space includes clinic rooms, luxury infusion therapy suites, and an area for specialized medical equipment for cancer patients. Designed to comfort patients and visitors, elements of nature are brought indoors and soothing artwork covers the walls.

## PROFILE IN GIVING: DEB MCCORMICK

---

“We need this level of care in Buffalo”

Deb McCormick lost her husband, David, in a plane crash seven years ago. And, her commitment to philanthropy helps her honor the six words that he lived by: Always give more than you take.

So perhaps it wasn't surprising that she was recently moved to support the Buffalo Hospital Foundation's Cancer Care campaign, which helped to create dedicated space for cancer care at Buffalo Hospital. It also supported the facility's designation as a Virginia Piper Cancer Institute® location. This collaboration with the award-winning Virginia Piper Cancer Institute – Abbott Northwestern Hospital and other Allina Health cancer specialists brings high-quality cancer care to Buffalo.

What was surprising is that a short time later, McCormick was diagnosed with cancer herself.

In February 2013, McCormick noticed redness and pain in her breast.

It was initially treated as mastitis, but when the condition didn't improve, doctors ordered a biopsy. She soon learned that it was cancer that had spread beyond the breast. “It's one of those diagnoses that you hear and you think, ‘this isn't happening to me,’” said McCormick.

As she decided where to seek treatment, she had the opportunity to meet with Nicole Hartung, MD, a Minnesota Oncology oncologist who cares for patients at Virginia Piper Center Institute – Buffalo Hospital. They both realized that they had already met – at the local breast cancer education event that had inspired McCormick to make her initial gift. Upon meeting Hartung again, McCormick said, “I knew that this was the person I wanted to walk my journey with.”

McCormick's cancer responded well to chemotherapy, which she was able to complete at Buffalo Hospital over a six-month period. She is now cancer-free and sees Hartung every three months.

“It's amazing how the team approach at Virginia Piper Cancer Institute – Buffalo Hospital comes together,” said McCormick. “There is so much compassion and sincerity.”

“I was moved to give, and I continue to give, because we need this level of care in Buffalo. The reality of cancer is that it hits one in three females and one in two males. It doesn't take much to do the math.”

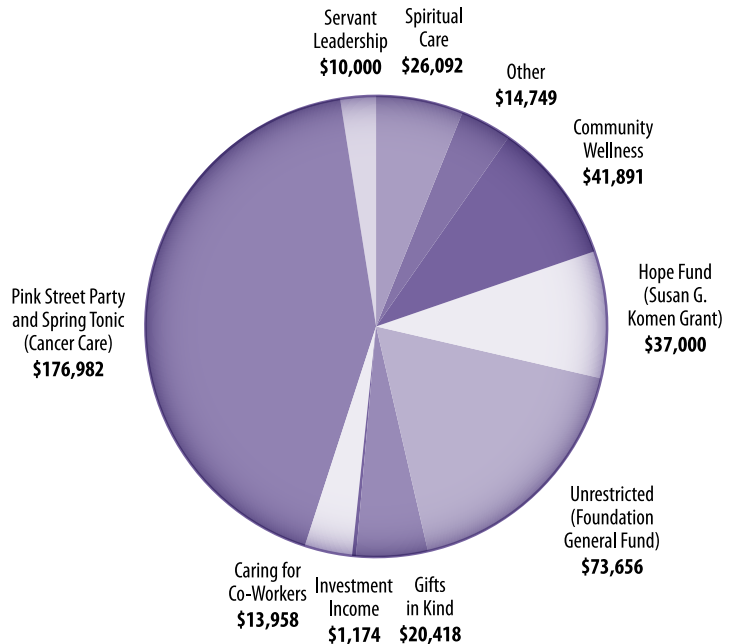
