This is exceptional news, as we continue the United Hospital Foundation Robotic Surgery Campaign. Our campaign is expanding the fleet of da Vinci robots available for our world-class physicians. 

Taking a sabbatical from practicing law to raise her family, Heller remained actively involved in various community philanthropic efforts. This includes serving three years on the Board of Directors for the North Oaks Golf Course, three years as a School Board Member and PAA President for St. Odilia School, six years as a Board of Trustee member for Hill Murray High School. In addition to her role on UHF's board, Heller also currently serves on the Foundation Board for Hill Murray High School.

Trustee of the Year: Cyndi Lesher



United Hospital Foundation's Trustee of the Year award was presented to Cyndi Lesher. Lesher is currently serving a second time with UHF in addition to serving on the Allina Health Subcommittee for Philanthropy. Lesher previously

served on the United Hospital Foundation Board of Directors and with the Allina Health Board of Directors.

Lesher is retired president and CEO, Northern States Power Company-Minnesota, an Xcel Energy company. She was appointed Volunteer Chair for the 2017 Super Bowl charged with recruiting, training and managing 10,000 volunteers. In January 2007, Lesher was named President of the Host Committee for the 2008 Republican National Convention, responsible for raising \$58 million to fund the convention and to showcase Minneapolis, St. Paul and Minnesota to the world.

She was appointed chair of the Governor's Workforce Development Council in 2004 by Minnesota Governor Tim Pawlenty. In 2003, she was inducted into the Women's Economic Roundtable, comprising the top 100 women leaders in Minnesota.

Lesher's leadership style has greatly benefited multiple nonprofits and organizations in the Twin Cities and beyond through her board involvement. "When there's a problem to solve, I'm not concerned with dogma or ideological preconceptions; I'm interested in what works. That's how I've approached my career in corporate leadership, and it's how I've approached my public service, including my work on the U of M Board of Regents and my tenure as chair of the Governor's Workforce Development Council."
