Board of Directors

Individual Director Roles and Responsibilities

Each individual director will function as a goodwill ambassador, representing the interests of the patients, donors and community that Mercy Hospital serves. Express unity of support for the hospital, its mission and its leadership by:

Fundraising

- Establish Mercy Hospital as a priority in your personal giving. Board members
 personally are asked (as a minimum contribution) to be members of the
 President's Circle (\$1,000 plus donors) and to contribute to fundraising
 events.
- Identify potential financial supporters to Mercy. Provide introductions/ assistance in connecting with prospects.
- Recruit President's Circle members.
- Assist in fundraising activities whenever possible or appropriate and attend fundraising events.

Policies and Standards

Follow bylaws and procedures and recognize and declare any potential conflict of interest.

Participation

- Participate in board retreats and educational activities.
- Become informed about Mercy Hospital its history, mission, vision, values, strategic goals, programs and staff.
- Be informed about and supportive of Allina Health and its mission: We serve
 our communities by providing exceptional care, as we prevent illness, restore
 health and provide comfort to all who entrust us with their care.
- Agree to receive communications from Mercy, the Foundation and Allina Health sent to board members and donors during board tenure and beyond.
- Serve a three-year term on the board. (Bylaws limit service to three consecutive three-year terms.)
- Prepare for, attend and participate in scheduled meetings of the board.
 The expectation is that a board member will attend at least 70 percent of meetings.
- Once board consensus is reached and a decision is ratified, be openly supportive of that decision, even if you disagreed during the approval process.
- Serve on at least one board committee. Prepare for and attend meetings. Participate in decision making.
- Respect the confidentiality and sensitivity of board and committee discussions.

Understanding

Understand the complementary roles of the foundation board, foundation management, hospital and Allina Health. Bring governance issues to the board chair or full board. Refer management issues to the Foundation President for resolution.

Mission:

The Mercy Hospital Foundation, a nonprofit charitable organization, raises, stewards and distributes philanthropic funds to support the health and quality of care of Mercy Hospital patients and families, and the health and wellness of the community we serve.

Overall Responsibilities of the Board of Directors

- Define, affirm and implement the mission of the Foundation.
- Participate in development of the short- and long-range plans of the Foundation, including the budget and fundraising plans, and to oversee the implementation of such plans.
- Review annually the performance of the Foundation against its plans, including review and approval of the annual financial audit.
- Oversee the work of all board committees.
- Set policy affecting the long-range wellbeing of the Foundation.
