# Expanding care at Buffalo Hospital

## Expanding care for our community

As we pursue our mission to bring exceptional health care close to home, we will be celebrating the opening of a new clinic location at Crossroads Campus Drive and County Road 35 in Buffalo. The new 15,000 square foot Allina Health Clinic is expected to open late July 2017, with a grand opening celebration this September. This new clinic will provide more space for our primary care providers and provide an Urgent Care option for our community.

"We want to help make it possible for everyone to receive health care in a comfortable and convenient setting, close to home," said Elizabeth Smith, MD, vice president of Allina Health clinics. "We are expanding the number of family medicine providers available to meet the need for primary care in Buffalo and the surrounding communities." Construction is underway and will feature a healing environment for patients, community members and guests.

## Changes on the horizon

With tremendous support from our community, Buffalo Hospital is excited about the opening of the Penny George Institute for Health and Healing on our campus this summer. Created in 2003, Penny George Institute for Health and Healing blends the art of healing and the science of curing to optimize the health of the whole person. With our thriving community wellness program, bringing Penny George Institute for Health and Healing seemed like a natural fit, expanding care for our community. Buffalo Hospital Foundation raised over \$200,000 to support a healing environment for Penny George Institute for Health and Healing.

The care at the Penny George Institute for Health and Healing, is grounded in focusing not just on injuries and illness, but caring for your whole being – mind, body and spirit. Whether you are looking for a nutrition consult, acupuncture, or want to participate in a healthy lifestyle program, Buffalo Hospital can partner with and empower you to tap into your body's own healing capabilities.

# Community Cancer Care Fund and Hope Fund

## We're here to help

The Buffalo Hospital Foundation has two emergency financial assistance programs to provide relief to those who find their cancer diagnosis to be a financial burden. The Community Cancer Fund, funded by proceeds from the Pink Street Party and individual donor gifts, is available to all those actively receiving care for all types of cancer. The Hope Fund is offered through a grant from the Minnesota Affiliate of the Susan G. Komen for the Cure® and is available for those who have been diagnosed with breast cancer.

Both funds were created to assist with basic living expenses such as mortgage or rent payments, utility bills, car payments, food, gas and other expenses.

*The Community Cancer Care Fund serves patients receiving care at Buffalo Hospital while the Hope Fund serves those diagnosed with breast cancer in Wright, Sherburne, Meeker and McLeod counties.*
