

Capital Campaign update: Hybrid Surgical Suite

Nasseff Heart Center is home to cutting-edge heart care

Many of you made the Nasseff Heart Center the home for outstanding heart care provided by doctors recognized around the world. Heart care is important at every age, but even more so to our aging population...one that is growing rapidly.

Health care changes so fast making it important to keep up with all the treatments needed for heart health. You can help make sure the Nasseff Heart Center continues to offer the best in heart care through a new, state-of-the-art Hybrid Surgical Suite. The suite will be a great addition to advancing our care for cardiovascular conditions.

A Hybrid Surgical Suite blends the capabilities of a cardiovascular catheterization laboratory, where minimally invasive heart procedures are performed, with a traditional surgical suite where open-heart surgeries are performed. The suite, which is large enough for a dozen clinicians to work seamlessly, also features robotic three-dimensional imaging.

Patients who benefit include those with:

- trauma requiring vascular and orthopedic repair.
- defective pacemakers leads. When pacemaker leads become defective, they
 need to be removed and could be done so more safely in a Hybrid Surgical
 Suite than in a traditional operating room where portable x-ray machines
 are used.
- congenital cardiac defects, such as "Structural Heart."
- abdominal aortic aneurysms (a blister on the main artery in the abdomen).
- abnormalities that develop with wear and tear of the valves and vessels of the heart wall, or through other disease processes.

Meet *Daniel Buss, MD*, Sports & Orthopaedic Specialists



When Daniel Buss, MD, joined United Hospital in 2015, it was with clinic partner Mark Heller, MD. Their goal was exciting: Build a Total Joint Replacement Center on United's Campus to help care for the growing needs of an aging but active

population in the east metro area. (Dr. Heller focusing on hip and knee; Dr. Buss on shoulder.)

A daunting vision but one that Dr. Buss is extremely qualified to fulfill.

In 1999, Dr. Buss founded Sports & Orthopaedic Specialists. Since then, it has grown into a nationally recognized orthopedic surgery and sports medicine practice. The practice serves not only Minnesota, but also many patients from North Dakota, South Dakota, lowa, Wisconsin, and across the United States through its eight clinic locations, including the one located at the Nasseff Specialty Center on United Hospital's campus.

At Sports & Orthopaedic Specialists, every surgeon has fellowship training or specializes in a particular portion of the body. Dr. Buss' area of speciality is in the shoulder and elbow.

Dr. Buss is a board certified Orthopaedic surgeon and a sub specialist in shoulders, elbows and sports medicine. Clinical partner, Dr. Heller, is a sub specialist in total joint replacement of hip and knee.

Said Dr. Buss, "Donations to the Foundation are used to put the personal touches on United's Campus. Like our office building," he continues, "the donations make it a beautiful and comfortable space for our patients and our staff. Patients really feel like they'll get great quality care when they walk in the door."

Surgery is done at the Elaine S. Larson Surgical Center. Renovations were completed just a few years ago with the help of donations to the Foundation. "The private preop rooms and the beautiful surroundings reduces our patients stress levels," said Dr. Buss.

A deep educational background, Dr. Buss earned his Doctor of Medicine from the University of Minnesota in 1983. After completing his residency at the Hospital for Special Surgery (a prestigious specialty hospital) through Cornell University Medical Center in New York City, he sought additional training through a Fellowship program in the areas of shoulder and sports medicine. He is certified by the American Board of Orthopaedic Surgeons, and is a member of the American Academy of Orthopaedic Surgeons. Other academic affiliations include membership in the American Shoulder and Elbow Society, the Association of Bone and Joint Surgeons, and the American Orthopaedic Society for Sports Medicine.

Dr. Buss's professional highlights include being recruited to the Minnesota Twins and serving as their team physician from 1990-2012. During that time, the Twins won the 1991 World Series. He was the medical director for the 1991 U.S. National Figure Skating Championships and the 1998 World Figure Skating Championships both held in Minneapolis.

Dr. Buss was born and raised in Southern Minnesota in the town of Claremont just 10 miles east of Owatonna. He has seven children, is married to his wife Christine and currently lives in the Lowry Hill area of Minneapolis.





Helping...it's what we do

There are many times when being fastest is the ultimate goal. In the world of Emergency Medical Services (EMS) quickly getting to a patient is important. In fact, most current ambulances were designed 30-40 years ago, when speed was most important. It took several tragic accidents to reveal the fact that a new, better ambulance was needed – one that provided for the safety of the patient and the clinical team while en route to a hospital.

Recently, Allina Health EMS started looking at ways to make that happen.

One of the first things learned seems obvious in hindsight: Unrestrained caregivers are likely to be injured regardless of vehicle size. In addition, the public is at greater risk when colliding with a larger vehicle. This realization focused efforts on finding a reliable, nimble, crashworthy ambulance.

Knowing that many minds are better than one, a design team consisting of mechanics, leaders and caregivers of various experience, sizes and shapes met to develop a list of desired features and specifications for a new ambulance. Bench seats and lap belts were out. Forward/rear-facing seats with shoulder belts were in. Safety, ergonomics and economics, in that order, became the team's focus. Clinicians needed to be seated and restrained while providing care in a moving vehicle. Weighty equipment was positioned to be easily accessible with good lifting technique. HVAC and electrical components were placed so mechanics could access them without the need for time-consuming disassembly. Controls were low-profile to reduce protrusions into the work space.

Next up was building a prototype, and finding the right manufacturer was easier than expected. Many were eager to help innovate and throughout the process, Crestline Coach stood out. Combining the new design needs and specifications with an already well-engineered ambulance worked well. The end result is quite remarkable.

"The state-of-the-art ambulance not only pushes the industry to rethink ambulance safety, but was also recognized with the 2016 EMS World Innovation Award for providing an innovative, new product.

This ambulance was on display at various conferences to help solicit feedback and ideas from other EMS professionals. The response has been very favorable. While many of the features included are not unique, industry experts think the combination is.

Allina Health EMS is excited to move forward with the new rigs. In 2016, 13 were ordered with plans for another nine for 2017 and nine more in 2018. And while we may be leading the way, we are not alone. Recently, two other EMS organizations purchased a Crestline ambulance based on our specs.

2016 Service to Humanity Physician Honoree

Pierce Vatterott, MD



Dr. Vatterott joined United Hospital in 1990 and found a perfect match between his professional passion and United Hospital Foundation's mission.

Professional passion meets Foundation support

"I was a seed that landed in fertile soil," he said about his early years at United.

An electrophysiologist, lead extraction is his professional passion and the Foundation has been critical to his successful practice at United. Through donations, the Foundation purchased a laser, the first of five in the U.S. at the time, to perform lead extractions. Now, 26 years later, more than 2,000 patients have had extractions at United Hospital.

His passion for cardiology stems from the unique combination of engineering, comparing a heart to an electrical system and pump, the caring aspects of medicine and teaching. Specializing in lead extraction was a natural fit – it correlates to high levels of engineering. Dr. Vatterott found this to be an area of great need. While lead removal significantly improves patients' lives, people were afraid of the risks. Not doing so, however, put their health and lives in danger. Dr. Vatterott understands this specialized, high-risk procedure and he excels at performing it safely.

For the past several years, he has partnered with the Foundation to put on an outstanding Lead Extraction Symposium to share those best practices and help improve the lives of many around the nation. In addition, Dr. Vatterott teaches at multiple national and regional

conferences across the U.S. He is assigned to Univerity of Minnesota cardiac EP fellows for education.

Practicing in the rich Twin Cities medical industry environment, he has been able to be part of research and development at Medtronic, Visible Heart Lab at the University of Minnesota, and lead extraction imaging research among many other projects.

Born in St. Louis, Missouri, Dr. Vatterott is one of nine children. Education, community involvement and service were strongly promoted in his family. He learned at an early age the importance of giving back. Building relationships are important to him and to this day he maintains friendships that began years ago.

A graduate of Mayo Graduate School of Medicine, Dr. Vatterott is a Merck Scholar of the American College of Cardiology in Electrophysiology Research, a Fellow of the American College of Cardiology and a Diplomate of the North American Society of Pacing and Electrophysiology. He is certified by the American Board of Internal Medicine in Internal Medicine, Adult Cardiovascular Medicine (Cardiology) and Cardiac Electrophysiology.

Today, he and his bride Teresa (Teri) live in Inver Grove Heights and have six children. They, too, have strong beliefs in education and among the six sons you'll find outdoorsmen, engineers, consultants, neuroscience researchers and a film maker.

With all the accomplishments he's made in his professional life, and the improvements he's made in the lives of countless patients, he's most proud of his children and the support of his self-proclaimed "bride." "Her support," he says, "is fantastic. It allows me to have this life." One filled with emergencies and long days. And United Hospital is grateful!



2016 Service to Humanity Community Honoree

Hubbard Broadcasting Foundation

The Hubbard Broadcasting Foundation was established in the late 1950s and supports many local organizations and causes throughout the Twin Cities and beyond. The family is very modest about their charitable contributions and focuses instead on their broadcast corporation – one that has provided an important service to our community for years.

Over 90 years of innovation

In 1923, Stanley E. Hubbard began his first foray into commercial radio through his 500-watt radio station, WAMD (Where All Minneapolis Dances) – the forerunner to KSTP-AM 1500. It was a humble beginning to what has become one of the most respected family-owned broadcast corporations in the world.

From 1923 to 2016, Hubbard Broadcasting has led the industry, becoming a corporation of firsts. The list is long and impressive. Highlights include: being the first national radio news service, buying the first TV camera ever sold, demonstrating the first TV set during the Minnesota State Fair, becoming the nation's first independently owned NBC affiliated TV station, broadcasting the first color program in the Midwest and then becoming the first full-color TV station in the world, and offering the first high-power Direct Broadcast Satellite programming direct to U.S. homes to name a few. They continue to look for innovative ways to connect with people and the community they serve through the medium of broadcasting.

Today, the Hubbard family remains actively involved within the corporation and the broadcast industry. They serve leadership roles in the corporation: Stanley S. Hubbard, the founder's son, Chairman and CEO; Stan E. Hubbard II, President, Hubbard Media Group; Ginny Hubbard Morris, Chair, Hubbard Radio; Rob



Hubbard, President, Hubbard Television Group; and Kari Hubbard Rominski, Executive Vice President, Community Affairs. As a family and as a corporation, they continue the strong tradition of serving our viewers and listeners through the Hubbard Broadcasting Foundation.

Hubbard Broadcasting operates radio and television stations in nine states. Other Hubbard Broadcasting companies include satellite and cable networks. ReelzChannel (launched in 2006) and Ovation TV, F&F Productions and the Hubbard Radio Network.
