## Sample of MN Title That Needs a Lien Release

When there is a first secured party listed on the title, the State of MN requires you turn in the lien release along with the title. This is required even though in most cases the loan has been paid off for quite some time. If you do not have a lien release, you must contact your lender and request one.

Other than signatures on the "seller's signature" line, no other information should be filled out. Our Title Specialist will take care of that on your behalf to assure correct completion. The back of the title is For Dealers Only. **Do not** write on the back of the title.
